Disability Workstream



Project Brief

The United Nations Development Program (UNDP) is working in partnership with the Disability Action Council (DAC), in coordination with the line ministries at the national and sub-national, the Disabled People's Organisations (DPOs) and NGOs, to contribute to the implementation of the National Disability Strategic Plan (NDSP2 2019-2023). The project aims to strengthen coordination and mobilise resources to implement the NDSP2 effectively at both national and sub-national levels.

Project Outcomes

- DAC effectively provides advice, coordinates, and monitors the implementation of NDSP2.
- Commune Investment Program (CIP), its budget and development process are disability-inclusive through the active involvement of DPOs/Cambodian Disabled People's Organisation (CDPO) and the provincial DAC mechanisms.
- DAC, Disability Action Working Groups (DAWGs) and Provincial DACs have the capacity to develop and implement disability-inclusive policies and budgets.

Key Interventions

- Support the national and sub-national coordination for NDSP 2 implementation.
- Support the amendment of the disability law and develop/review the national legal frameworks related to disability.
- Support DPOs to engage in CIP development and provide training in disability and inclusive CIP development.
- Promote disability-inclusive CIPs in selected communes, and document lessons learnt for replication.
- Build capacity of DAC, DAWG and Provincial DAC in disability inclusion, and inclusive planning and budgeting.

COVID-19 Interventions

- Produce five video spots to raise awareness on COVID-19, specifically in the context of persons with disabilities. The videos are being developed and are expected to be shared publicly by the mid of June 2020. The video will be shared using different media sources, such as social media and local TV channels.

Beneficiaries

- Direct: Persons with diverse disabilities including women with disabilities.
- Indirect: Family of persons with disabilities, community, local authorities, and government officials.
