



Terms of Reference Situational analysis of persons with autism in Cambodia

Background

Disability Prevalence

Globally, disability prevalence represents 15% among general population or one in seven¹. However, this prevalence is varying from one study to another, such as the 2014 Cambodia Demographic and Health Survey (CDHS) for the first-time using Washington Groups Short Set (WGSS) questions identified 9.5% of disability prevalence among population five years and over, and the recent 2019 national Census that used WGSS questions for the first time too identified prevalence of disability of 4.9% among the same group. Furthermore, according to a 2012 report by WHO, children with mental or intellectual disability are 4.6 times more at-risk for sexual violence. In addition, persons with disabilities have been disproportionally affected by COVID-19. Available data shows that people with disabilities are far more likely to contract the illness and die once diagnosed.²

The most recent national Census 2019 identified disability prevalence at 4.9% among population of five years-old and over. Seeing difficulty is the highest at 3.5%, and remembering, self-care and communication difficulties represented

2.7%, 2.3% and 2.3% respectively. Disability prevalence increase along the age group from 1.4% among population aged five to 14 years to 25.6% among 60 years and over³.

Autism in Cambodia

Although there has been improvement in the data collected on disability through national surveys and the census in Cambodia, **specific information related to children and adult with autism** remains very limited.

The limited data on autism that is available is: from the Centre for Children and Adolescent Mental Health (CCAMH)⁴, which diagnoses three to five children with Autism every day. The same source of information said that most parents first seek out traditional healers and monks to treat their children with intellectual impairment. This is likely to result in under reporting of situation of autism.

Support services for children with autism remain very limited. In addition to CCAMH, a few more public and NGOs facilities provide some support. These include Hand of Hope Community (HHC), Rabbit school, PHACHID⁵.

Access to Services

In general, access to support services for persons with disabilities is challenged by several barriers that include the financial barriers, limited knowledge and skills of health staff and discriminatory attitudes toward persons with disabilities, persons with disabilities and their family having poor knowledge of where to seek appropriate services, sociocultural negative beliefs and attitudes associated with disability, long distances to health facilities, lack of appropriate transport options and inaccessibility of health facilities. Very little is known about the specific barriers that people with autism and their families experience in accessing services.

Legal and Policy Framework

Cambodia's Law on the Protection and the Promotion of the Rights of Persons with Disabilities requires the government to protect the rights and freedom of persons with disabilities, to prevent, reduce and eliminate discrimination against persons with disabilities, and to provide them with appropriate rehabilitation services in order to ensure their full and equal participation in society.

Under the leadership and coordination of Disability Action Council (DAC), new disability law currently in process of being developed that will more clearly articulate the rights of people with disabilities and responsibilities of public and private legal entities as duty bearers to satisfy these rights in line with the Government of Cambodia's commitment to the United Nations Convention on Rights of Persons with Disabilities (UNCRPD).

To contribute to the implementation of the above law as well as other legal

instruments, the Secretary General of DAC (DAC-SG) has requested for support to conduct an assessment of the situation of persons with autism in Cambodia aiming to provide clear evidence for further policies and programs formulation.

The objectives of this consultancy

- 1. To undertake an assessment and analysis of the support services available to persons with autism;
- 2. To analyse the situation of persons with autism in accessing support services, that may include facilitators, barriers and challenges; and
- 3. To make recommendations for on options to strengthen support services, including but not limited to education, rehabilitation and vocational skills training.

Scope of Role

The consultancy will report to the assigned DAC-SG focal person in close coordination with ACCESS Disability Lead.

The selected consultant(s) will:

- Liaise and coordinate with DAC-SG and ACCESS, starting by a kick-off meeting and to plan the work and at each stage of the consultancy
- Provide inception report that should include proposed structure of the report, methodologies and clear timeframe and incorporate feedback from DAC-SG, ACCESS and other relevant counterparts.
- Conduct a document review on autism from Cambodia, regional and wider global publications and material
- Complete Key Informant Interviews (KIIs) and Focus Group Discussions (FGDs) including people with autism, family members and caregivers, service providers and policy makers
- Analyse data and prepare detailed report including documentation of work carried out and finding as well as recommendations for future interventions.
- Present the key findings to relevant stakeholders
- Finalize report including all stakeholders feedback and submit to DAC-SG and ACCESS.

Timeline

This assignment is for an estimated 30 to 35 days. The accurate level of effort and corresponding budget can be readjusted based on the approval of inception report. Tentative timeline is as follows:
