Gender-Based Violence Workstream



Project Brief

The project will support the implementation of the third National Action Plan to Prevent Violence Against Women (NAPVAW 3). It will enhance Ministry of Women’s Affairs (MoWA) capacity to effectively coordinate the Gender Based violence response coordination at national and local level and the provision of quality inclusive services for women as well as lead evidence-based advocacy for national budget allocation for implementation of the strategic priorities of NAPVAW 3.

Project Outcomes

- Duty bearers in target locations provide quality inclusive services to women affected by GBV in compliance with formally adopted essential service standards.
- The Technical Working Group for Gender sub-committee on GBV (TWGG-GBV) under MOWA leadership holds members accountable for the coordinated implementation of the 3rd NAPVAW at national level and subnational levels.
- GBV Working Groups coordinate quality multi-sectoral services, case management and referral.
- MOWA leads evidence-based advocacy for national budget allocation for implementation of the strategic priorities of the 3rd NAPVAW.

Key Interventions

- Support coordination at national and subnational levels and links between various levels
- Develop user friendly guidelines and training tools on existing frameworks (Mediation, Training for Judicial Police Officers/Agents (JPO/JPA))
- Review Training of Trainers of GBV working groups
- Training GBV working groups on essential services packages
- Support MoWA advocacy to increase budget allocations to GBV by Line Ministries

COVID-19 Interventions

- Participate in MoWA led discussion on COVID-19 response in the GBV sector.
- Adjust implementation modalities to finalise GBV essential service standards despite physical distancing constraints through the use of remote consultations and online meetings.

Beneficiaries

- Direct: Government agencies, Legal Protection Department, MoWA, TWGG-GBV Secretariat and members, Subnational GBV Working Group members and service providers
- Indirect: families and communities of women who experience GBV

Kampong Speu, Preah Sihanouk, Siem Reap plus provision of support to MOWA's national level coordination role on violence against women
